PET FOOD RECALL

By now most of you are very aware of the recent dog and cat food recall. If you are looking for more information or updates, you can visit the following websites: www.menufoods.com or www.fda.gov. You will find the list of companies, foods, etc. that are included in the recall.

Below is an excerpt from testimony on the FDA's website regarding the recall:

Scope of the Pet Food Recall

"To date, manufacturers have voluntarily recalled more than 100 brands of dog and cat food across the nation. Manufacturers participating in the recall of pet food products include: Menu Foods, Hill's Pet Nutrition, P&G Pet Care, Nestle Purina PetCare Company, Del Monte Pet Products, and Sunshine Mills. The importer, ChemNutra, has also recalled the raw ingredient, wheat gluten. Although this is one of the largest pet food recalls in history, according to the Pet Food Institute, a trade association representing pet food manufacturers, the product recalled currently represents less than one percent of all dog and cat food on the market. This indicates that consumers have

access to an ample supply of pet food to meet the needs of their pets. Nonetheless, we recognize the serious risks that the contaminated pet food represents to pets that consume this food, which is why we are devoting the resources needed to assure the success of the investigation and the pet food recall.

To ensure the success of the pet food recall, FDA is working with the recalling firms and with our many public health partners. We are cooperating with the 50 state departments of agriculture, health authorities, veterinarians, the Association of American Feed Control Officials. FDA is also conducting recall effectiveness audits to ensure manufacturers and other recalling firms remove the recalled product from the pet food supply chain."



HSSC MINUTES

The meeting was called to order on March 3, 2007 at 8:20 P.M. The members, directors and officers present included John Limpert, Kristin Hauser, George Huddle, Linda Limpert, Greg Dineen, Judi Hornbacher and Carol Kruger.

Old Business

The minutes from the January 14, 2007 meeting were reviewed, and there being no objections or additions, they were approved as read.

The membership has grown and the secretary will send the updated list to all of the officers and directors. It was recommended and agreed that we will also prepare a contact list of individuals who may have an interest in the club, such as new puppy owners, former members, etc. They will be added to the list of individuals who receive the electronic newsletter.

August, 2007 Specialty

George Huddle has received some preliminary information from Sue Stoterau regarding the requirements for awards needed for our club Specialty in August. He noted that the deadline for a response specifically describing our awards is April 1, 2007.

Discussion continued regarding possible awards on hand, their quality and quantity, and whether there was a need for additional items.

{John mentioned that a secretary is needed for agility}

Further information is needed on exactly what type and quality of awards are acceptable to the Lake Elmo club officials.

Additional contact information is also needed for rally and obedience, and John and Linda will follow up with Sue Stoterau to obtain that information.

Previously a motion was approved to provide a sup-

ported entry on Monday, and at this time a motion was unanimously approved to also provide a supported entry for Sunday.

Following further discussion a motion was passed to provide upgraded ribbons on both Saturday and Sunday. A motion to provide a toy to each entrant in both sweepstakes and regular entries was made and passed unanimously, along with a motion to provide a gift package of treats and toys for all participants in Sweepstakes.

It was determined that upgraded ribbons will be provided to all of the following regular classes:

- Best of Breed, Best of Opposite Sex, Winner's Dog, Winner's Bitch, Veteran's Dog, Brood Bitch and Stud Dog.

In Sweepstakes upgraded ribbons will be presented for Best Puppy and Best Veteran.

A supported entry donation for the Northstar Working Group Association was approved.

Fundraising ideas, including shirts with the club logo, etc., were briefly discussed. It was decided that an article should be inserted in the newsletter to see if there is enough interest on the part of the membership. In general more information is needed on both interest and costs.

There was a brief discussion of our insurance coverage, and John Limpert will continue to gather information for discussion at the June meeting.

At the same time we will discuss ideas on necessary revisions or updates to the Bylaws.

We need to prepare a letter to the AKC requesting
