

AKC and VVMA Express Outrage at PETA Approach to Euthanasia in Animal Shelter (Wednesday, July 10, 2013)

The American Kennel Club® (AKC) and the Virginia Veterinary Medical Association (VVMA) have today issued statements to highlight their vehement disapproval of People for the Ethical Treatment of Animals (PETA)'s apparent policy of euthanizing animals frequently at its shelter in Norfolk, VA. Furthermore, the AKC has called for the PETA shelter to take steps towards balancing its adoption and euthanasia rates for dogs and cats in its shelter.

"While most shelters strive for a 90% re-homing rate, PETA is apparently proud of their 99% killing rate and callously boasts that the animals it rescues are 'better off dead'. That is an alarming ratio that should be fully investigated. PETA's track record is absolutely unacceptable," said AKC Chairman Alan Kalter. "Legitimate animal shelters in America re-home most of their sheltered animals. If some of Michael Vick's fighting dogs can be rehabilitated and re-homed then PETA can – and should – do better. If they cannot – or will not – then they should leave sheltering to others."

"Re-homing a dog is not always the easiest but it is AKC's preferred route. PETA's apparent lack of commitment to re-homing is hypocritical. Our experience, through AKC clubs' rescue network, proves that a rescued dog can often thrive if given the much-needed love, medical care, rehabilitation and responsible placement into a new home. AKC is disgusted that euthanasia is seemingly so easily employed by PETA."

"While it is true that some animals at shelters are too physically injured or psychologically scarred to be adoptable, many of them can be successfully treated, rehabilitated and adopted, said VVMA President, Mark Finkler, D.V.M. "Veterinarians throughout Virginia work with numerous shelters and rescue groups to assist in the care of these dogs and cats. It is disappointing to hear that PETA has a different philosophy regarding the handling of these abandoned and unwanted pets."

FIVE CANINE HEROES HONORED WITH AKC® HUMANE FUND AWARDS FOR CANINE EXCELLENCE (ACE)

New York, NY – The AKC® Humane Fund celebrates the loyalty, devotion and strength dogs share with us by announcing today (August 19th) the winners of the 14th annual *AKC Humane Fund Awards for Canine Excellence* (ACE), which commemorate five hard-working dogs that have made significant contributions to their communities. The awards are presented in each of the following five categories: Exemplary Companion Dog, Law Enforcement, Search and Rescue, Service and

Therapy. This year's winners include a Newtown therapy dog and an active amputee that helps wounded warriors overcome their own injuries.

"The dogs honored by the ACE have contributed immeasurably to the lives of individuals and communities across the country, and with so many great stories, it's difficult to choose just one recipient in each category," said AKC Spokesperson Lisa Peterson. "We're proud to award these five deserving dogs with AKC Humane Fund Awards for Canine Excellence."

All the ACE recipients will receive \$1,000 to be awarded to a pet-related charity of their choice and an engraved sterling silver medallion presented at the AKC/Eukanuba National Championship in Orlando, Florida on December 14, 2013. This year's ACE winners include:

Exemplary Companion Dog: "Bart," a Vizsla owned by Darcy Hodges of Brooks, Georgia

Therapy Dog: "Drago," a Spinone Italiano owned by Lauren Friedman and Chris Sweetwood of Milford, Connecticut

Service Dog: "Tuesday," a Golden Retriever owned by Capt. Luis Carlos Montalván of New York, New York

Law Enforcement Dog: K9 "Zeke," a Belgian Malinois handled by Cpl. Tyron E. Meik of the Harrisburg (Pennsylvania) Police Department

Search and Rescue Dog: "Jesse," a German Shepherd Dog owned and handled by Susan Condreras of Riverhead, New York

2013 AKC/EUKANUBA NATIONAL CHAMPIONSHIP AGAIN RAISING THE BAR

New York, NY (August 30, 2013) — The AKC/Eukanuba National Championship (AENC) returns December 10-15, 2013 to Orlando's Orange County Convention Center. Already one of the world's premiere dog events, the 2013 event will offer All-Breed competitions, Specialty competitions and Special Attractions, Breeder Seminars, Companion events, Consumer attractions and of course the crowning of a new National Champion. With an enhanced event schedule and expanded online coverage, this year's Show Planning Committee is creating a truly one of a kind event.

For those who can't be in Orlando in person, free coverage via streaming video will be aired from the event. Dozens of cameras will deliver more than 300 hours of video coverage from a selection of Friday Specialties and Special Attractions plus every Breed, Group and Best in Show competition taking place over the weekend. The breed judging for all 190 breeds and varieties will be available in its entirety as streaming video, while all evening group and Best in Show judging will be aired live from the show floor, all accessible from www.akc.org.

"Last year, the inaugural live streaming of the AKC/Eukanuba National Championship garnered more than 1.3 million views, and provided wider reach than the TV broadcast," said Jason Taylor, Communications Director for P&G Pet Care. "We'll build on that success by offering this year's event exclusively online, and with our enhanced format and expanded coverage, we expect to easily reach more than 2 million viewers. We are excited to air the event via this state of the art technology and look forward to sharing the event with dog lovers around the world, especially those who have never even seen a dog show."

"Sporting events are magical when viewed live. Streaming video gives us the ability to showcase every dog that walks into our rings," said Michael Canalizo, AKC/Eukanuba National Championship Event Manager. "There is no limit to how many people can watch an event streaming live, this is how people digest media today and it is exciting for us to be on the cutting edge."

Ron Menaker, Show Chairman for the AKC/Eukanuba National Championship since 2002, has chosen to hand over the reins to Dennis Sprung, who has served as Assistant Show Chairman since 2005. "I am delighted to have recommended Dennis Sprung as the new Show Chairman for the AKC/Eukanuba National Championship," said Ron Menaker. "We worked together for many years on this important event and I know that in his hands, it will continue to be one of the dog world's premier shows."Mr. Menaker was responsible for numerous enhancements and successes while serving as Show Chairman, including the event's emphasis on honoring the breeder and its expansion to international participants.

"Ron's dedication to the sport of purebred dogs has been demonstrated not only by his outstanding service as Chairman of the American Kennel Club, but also in his leadership as Show Chairman of this internationally respected event," said AKC President and CEO Dennis Sprung. "We appreciate the enormous work he has done and know it has laid the foundation for the AKC/Eukanuba National Championship to continue to grow."

Eukanuba's Jason Taylor will serve as Assistant Show Chairman. Sprung and Taylor join Michael Canalizo, Gina DiNardo and Victoria Seiler to comprise the National Championship's Event Planning Committee.


In late June, Von Rose Masked Phantom "*Phantom*" had the opportunity to meet his dad, Zorro.
